

## 1) Your Contract with Us

- a. When the Hirer signs this Rental Agreement they accept the conditions set out here in (this document will be presented to the Hirer before departure and must be signed before departure).
- b. Please read this agreement carefully. If there is anything you do not understand or do not agree with, please ask a member of Lazy Days Campers.

## 2) Rental Period

- a. I will have the vehicle for the rental period shown at the end of this agreement. The rental period will be shown with time and date of departure and time and date of return of the vehicle. If you do not bring the vehicle back on time you are breaking the conditions of this agreement. We reserve the right to charge you a late return fee if the vehicle is not returned by the time stated at the end of this agreement.

## 3) Hirer's Obligations

The Hirer is responsible for:

- a. Driving the vehicle in a cautious, prudent and normal manner.
- b. Any damage to the vehicle, any of its parts or any of the equipment provided with the van.
- c. For any loss or damage to additional equipment hired at the time of rental, including but not limited to equipment hired at the time of rental.
- d. The Hirer must ensure they look after the vehicle and the keys to the vehicle. The Hirer must always lock the vehicle when not using it and use any security device supplied with the vehicle.
- e. Ensuring the correct fuel is used – our campers use Unleaded Fuel.
- f. The payment of reasonable costs if Lazy Days Campers have to pay extra costs to return the vehicle to its condition when the pre-rental inspection was carried out (for example, if extra valeting time or special material or equipment is needed to restore the vehicle to its pre-rental condition) or if the vehicle has been damaged internally or externally whilst in the Hirer's care.
- g. Ensuring you do not sell, rent or dispose of the vehicle.
- h. Ensuring no one works on the vehicle without Lazy Days Campers permission.
- i. Ensuring the Hirer contacts us as soon as possible and within a maximum of 12hrs of having an accident and/or any fault with the vehicle.
- j. For returning the vehicle to the place agreed on departure on time and on the date specified at the end of this agreement.

The Hirer or any other driver named at the end of this document must not:

- a. Allow the vehicle to be driven by anyone other than yourself or the named driver.
- b. Use the vehicle for hire or reward.
- c. Use the vehicle for any illegal purpose.
- d. Use the vehicle in a manner, which could cause damage.
- e. Use the vehicle to carry more persons than are permitted by any relevant authority or detailed in this agreement.
- f. Use the vehicle while under the influence of alcohol or drugs.
- g. Use the vehicle or allow it to be used off road or on roads unsuitable for the vehicle.
- h. Smoke within the vehicle or any hired Awnings etc.
- i. Cook within the vehicle
- j. Leave Pets unattended in the vehicle or any hired awnings.

## 4) Our obligations

- a. Lazy Days Campers have maintained the vehicle to a high standard to ensure to the best of our ability that the vehicle is roadworthy and suitable for renting at the start of the rental period. We will show you how to use the vehicle, answer any questions you have before you depart and go through this Agreement with you before you are expected to sign it.
- b. In the event that the vehicle is unavailable for reasons out of Lazy Days Campers control, such as the vehicle has been involved in an accident prior to the agreed Vehicle collection time, Lazy Days Campers will endeavor to provide a replacement vehicle. If a replacement vehicle is unavailable then Lazy Days Campers will refund all monies including your initial booking fee of £150.
- c. Lazy Days Campers will not be held responsible for consequential loss in the event of a replacement vehicle being unavailable.

## 5) Road/Driving Restrictions

- a. All Vehicles may only be driven on sealed / bitumen roads.
- b. Lazy Days Campers reserves the right at any time, at its sole discretion, to restrict vehicle movements in certain areas due to adverse road or weather conditions or any other reasonable cause.
- c. The vehicle must not be driven above 60 MPH.
- d. There is no maximum mileage, however average miles of more than 100 per day of hire shall be charged at a rate of 20p per mile.

## **6) Insurance and damage protection**

- a. The Vehicle is insured for damage and the property of a third party;
- b. The Hirer will have to pay an excess on any insurance claim. The insurance excess is **£500.00**.
- c. The Hirer will not have any insurance cover and will be responsible for the total cost of any damage if they breach any of the terms of this agreement and/or the Terms and Conditions.

## **7) Charges**

The Hirer is responsible for paying Lazy Days Campers the following charges:

- a. All rental and any other charges calculated in accordance with this agreement.
- b. A late return fee of £20 per hour if the vehicle is not returned on time (Lazy Days Campers expect the hirer to return the vehicle on time as vehicles will require maintenance and inventory checks and need to be cleaned before being rented out again that same day).
- c. The nominated valeting fee of £25 per hour of cleaning required by if the camper is not returned with the interior in a clean condition.
- d. The nominated cancellation fee in the event of cancellation of this agreement prior to the hire.
- e. The cost of any damage to the camper or the property of any third party, subject to the insurance cover.
- f. All fines, court costs and intended prosecutions for parking, traffic or other offences (including any costs which arise if the vehicle is clamped). The Hirer must pay the appropriate authority any fines and costs if and when the authority demands payment.
- g. A refueling service charge of £15 plus the fuel required to fill the tank if the Hirer has used, and not replaced, the quantity of fuel that Lazy Days Campers supplied at the start of the original rental.
- h. The cost to recover a Vehicle, which has become bogged/stranded (this cost will vary depending on severity of the accident and the location of the vehicle).
- i. All charges and expenses payable by you the hirer under this Agreement are due on demand by Lazy Days Campers. If you the hirer does not pay all charges when due, the hirer agrees to pay a late charge of 1.5% per month on the outstanding balance and any collection costs incurred by Lazy Days Campers, including legal fees. When the Customer comprises of more than one person, each person is liable jointly and severally for all obligations of the customer pursuant to this Agreement.

## **8) Accidents**

In the event of an accident and or loss or damage arising out of the use of the Vehicle the Hirer must:

- a. Notify Lazy Days Campers within 12hrs of the accident.
- b. Obtain the names and addresses of third parties and any witnesses and report the event to the police.
- c. Obtain the insurance details of third parties, third party vehicle registration and where possible take photos of the incident.
- d. Make no admission of liability to other parties, settlement offer or other like offer.
- e. Assist Lazy Days Campers in handling any claim arising from any event, including providing all relevant information and attending Court to give evidence if required.
- f. Acknowledge that the excess of £500 or other amount payable the Hirer in respect of any damage arising from an accident, loss or damage is payable at the time of reporting the event and not at the completion of the rental period.

## **9) Maintenance**

- a. The Hirer acknowledges that they should take all reasonable steps to properly maintain the Vehicle, including oil checks, water and batteries.
- b. The Hirer acknowledges that Lazy Days Campers will reimburse for expenditure up to UK£100.00 reasonably incurred in rectifying any mechanical failure to the drive train and engine of the Vehicle (not including the water system, refrigerator, heating, and audio equipment) provided that the Hirer can produce the relevant receipts, have received the prior consent of Lazy Days Campers and the damage is not due to my fault or my breach of this Agreement.
- c. Subject to the terms of this agreement, you the hirer will pay for the cost of repairing or replacing tyres damaged during the Rental Period provided that Lazy Days Campers will reimburse me for expenditure reasonably incurred if the Hirer can produce relevant receipts, the tyre is defective and is returned by the Hirer to Lazy Days Campers for inspection and the manufacturer accepts liability under his warranty.
- d. The Hirer will be liable for any costs associated with the incorrect use of fuel (our vans use Unleaded)

## **10) Collection/Delivery & Return of the Vehicle**

- a. The Hirer will acknowledge receipt of the Vehicle in a clean condition and in sound working order in accordance with the Departure Checklist and with a full fuel tank and one full and one partially full gas bottle before departure with the van (the Rental Agreement will be produced for signature prior to departure).
- b. The Hirer will adhere to the collection and/or delivery and return times shown at the end of this Agreement (the vehicle will be available for collection between 13.00 and 14:00 on the day of collection (the day hire commences) and must be returned between 9:30 - 10.30am on the return day (the day the hire ceases).
- c. The Hirer will return the vehicle in a clean condition with a full tank of fuel by on the final day of hire.
- d. The Hirer acknowledge that Lazy Days Campers will not refund to me any monies and are under no obligation to provide a replacement vehicle if the Vehicle is returned or The Hirer ceases to have the use of the Vehicle prior to the return date for any reason including accident, weather and theft.

This is the final page of this document and needs to be completed and signed by both parties on collection of the vehicle.
